TERMS AND CONDITIONS

- I hereby authorize the Romeoville Recreation Department to charge the amount shown above to the indicated credit/debit card account. The authorization granted includes the authorization to charge the indicated credit/debit card any recurring monthly fee or fees required by the program(s) for which I am registering.
- To prevent interruption or termination of my access to programs or services the Romeoville Recreation Department must be informed of any account changes by the 15th of the month prior to the month in which such changes are to become effective.
- A \$35 fee will be charged for any transaction returned unpaid for any reason, including but not limited to account closures, credit card rejection, insufficient funds, revocation of this authorization, stopping payment, or any other circumstance where payment due cannot be collected when due. Any transaction remaining unpaid for five (5) days after the Romeoville Recreation Department attempts to make contact concerning payment using the information provided above shall result in the suspension of eligibility for or access to the Romeoville Recreation Department programs, services or facilities in question. The occurrence of three such unpaid transactions during any 12 month period shall result in termination of eligibility for or access to the Romeoville Recreation Department programs, services or facilities in question.
- Charges will be made to the account each month on the day of enrollment or within a few days after the enrollment date.
- **FIT 4 LIFE MEMBERS ONLY:** This authorization and FIT 4 LIFE membership may be canceled at any time and upon thirty (30) days' written notice in the event that a member moves from the address provided above or becomes deceased or medically or physically unable to continue FIT 4 LIFE fitness activities. The Romeoville Recreation Department may require reasonable documentation of these conditions.
- **FIT 4 LIFE MEMBERS ONLY:** FIT 4 LIFE members desiring to terminate this authorization and FIT 4 LIFE membership for reasons other than those set forth above may do so at any time upon thirty (30) days' written notice. If a membership is terminated within the first 24 months, a \$25 termination fee will be assessed for each member cancelled. In addition, if the primary member cancels, a remaining additional member fee will be increased to a primary member fee (if applicable). Members also remain liable for all charges accrued prior to the effective date of any termination.
- The Romeoville Recreation Department may terminate eligibility for or access to the Romeoville Recreation Department programs, services or facilities in question in the event of conduct by any party registered to participate in or use the same that violates the applicable policies of the Romeoville Recreation Department, the ordinances of the Village of Romeoville or other applicable law.
- I agree that fees may change with at least 30 days notice in writing from the Romeoville Recreation Department.
